# **Labor Council To Welcome New United Way Director**

Mike Rubino, newly appointed director of the United Way of Beaver County, will be welcomed at the delegates meeting of the Beaver/Lawrence Central Labor Council on January 19th, 2015, at the IBEW Local 712 Union Hall in Vanport at 7:30pm.

The AFL-CIO and the United Way have a long tradition of working together to help workers, families and communities in need, says Rich Trumka, President of the National AFL-CIO.

We are continually looking for opportunities to join forces to help working families, particularly in the areas of education, income and health.

Since 1946 the AFL-CIO has partnered with the United Way of America and I encourage each of you to participate in this year's United Way Campaign.

The AFL-CIO and the United Way have enjoved a cooperative relationship for nearly 70 years as they together provide services to members of organized labor, their families and their communities. The partnership allows organized labor leaders to train union members about health and human services organizations that are available to assist those in need.

Labor leaders are recruited, trained and placed on decision making bodies of health and human service organizations at the national, state and local levels. Organized labor solicits contributions from workers through payroll deductions that account for approximately two thirds of the funds that the United Way raises each year.

The United Way and organized labor work

together to provide more than 160 full-time AFL-CIO Community Service Liaisons to serve as links between their state federations, central labor councils and United Ways in 165 communities across the United States. In addition 18 local labor agencies and four state labor agencies receive direct United Way Support.

The United Way serves as a full partner to the National Association of Letter Carriers (NALC) annual food drive on the second Saturday in May each year. The partnership between the NALC, AFL-CIO and the United Way has stocked the shelves of local food banks, pantries and shelters with nonperishables that letter carriers collect from customers along their mail routes for many vears.

Early last year, when we started to plan our Human Rights Banquet, the Reverend William Barber was mentioned. After we read more about him, we decided that we wanted to have him as our Keynote Speaker. At that time, and presently, he is sponsoring protests in Raleigh, North Carolina, to make

a statement to the Governor and State Legislators to be moral after they enacted Voter suppression and Voter ID legislation.

Protests are held one Monday per month. Thanks to the help of the Labor Council. six of us went to Raleigh for this. There were 80,000 people there. Thanks to Willi Sallis and Steven Kocherzat. 1000 people. It was a great event we were able to secure Reverend Barber as speaker for the Banquet. In his speech, he asked us to make a pledge to have a Moral Mondays protest in Harrisburg. SEIU supplied the vans and lunch, and a small group of us held a protest on the Capital steps.

> We started having Moral Mondays meetings. Then on October 27th, we had our first protest on the steps of the Beaver County Court House with speakers. There was a great turnout. ## Interview with Father John O'Malley

Father John O'Malley has been a long time supporter of civil rights and labor. He is now retired from the Catholic Diocese but remains active in his interest.

He was born and raised in Pittsburgh, one of a family with seven children. He was an accomplished athlete, playing basketball for St. Francis College, and signed briefly with the Detroit Pistons as a free agent. Yet he was still thinking of becoming a priest.

Playing basketball was what gave Father Jack insight into his own prejudice and values. His roommate in college was African-American and Father Jack learned about his roommate's issues as a black man in the late 50's.

Father Jack had the opportunity to make a stand when his basketball team was stranded in Winston-Salem, North Carolina at the airport. The white players could stay at a hotel but the black players would have to spend the night at the airport. All of the players decided to spend the night together at the airport.

This was the beginning of his legacy as a champion of civil rights, advocating for justice for workers and the working poor. He was ordained in Pittsburgh in 1965 and now we are here to talk with him about his work.

Q: People seem to have difficulty combining the church and the labor movement. How do you help people to see the need for these two entities to help each other?

A: We are faith based and my neighbors needs help because they don't make a living wage and they don't have insurance. The churches took in immigrants because of the barriers such as language and finding work. Economics can break up families. When families don't make enough money to survive, the family structure fails and they break up. This is where the church needs to become involved. The church 's involvement depends on the Bishop. Bishop Zubik is very understanding that the needs of the community and labor are joined and need each other to survive.

Q: Have you heard of Rev. William Barber?

A: I have been following him and his Moral Monday's Movement for several years. I met him when he was in town for the Beaver County Labor Council Human Rights Banquet. I wanted to meet him and tell him what I think of him. I think he could be the next Martin Luther King.

Q: Are you still involved with IWJ (interfaith worker justice)?

A: The IWJ started in Chicago, IL, and is a nation-wide organization that strives for rights for the working poor everywhere.

Clergy from many faiths come together to help people achieve justice. The clergy participate in rally's and protests at worksites to inform the public and corporations of the basic needs and rights of the emplovees. I am still involved with IWJ. I participate in conference calls. This is why the church really should be involved. It is about family, family values and that is what church is all about. IWJ challenges the clergy to "Spread the Gospel and if need be, use words." The cleray need to live with the workers.

Q: What are you doing currently?

A: I work with PIIN. (Pittsburgh Interfaith Impact Network). We were arrested while trying to block the doors at UPMC. Nine clergy were arrested that day and when we went to court, the magistrate asked us if we were witnessing the gospel for people to make a living wage. The magistrate told us "It sounds like you were just doing your jobs. Case dismissed. Now get out of here."

#### USPS Tells Customers: Abandon Neighborhood Post Offices; Go to Staples

Postal management has launched a new offensive – one that clearly reveals the sinister goals of its no-bid deal with Staples.

The USPS is now using postal funds to mail ads for 20% discounts on USPS shipping services at Staples stores. The intent is clear: to incentivize customers to abandon their neighborhood post offices in favor of the private office -supply retailer.

Next, management will almost certainly conduct a study and discover that traffic is down in post offices. And they will say that justifies reducing service hours and work hours or closing the offices completely.

This ad underscores why we must continue to fight the Postal Service's dirty deal with Staples. Postal workers and customers are responding by returning the ad to sender.

Here's what you can do:

- Post a picture of yourself with the ad or with a note card where you've written, #ReturnToSender on <u>Face-book</u> or <u>Twitter</u>.
- Ask your family and friends to do the same. And ask them to take their business elsewhere until Staples gets out of the postal business.
- If you receive a coupon in the mail, cross out the address and barcode, write "Return to Sender," and drop it in the mail.
